

# Excerpt from the Decision on Pricing related to payment services provided to non-consumers

Applicable as of April 1, 2026

## GENERAL PROVISIONS

1. OTP banka dioničko društvo (hereinafter the Bank) collects fees for the services it provides, in accordance with the provisions hereof (hereinafter referred to: the Decision).  
In addition to this Decision, in retail banking this matter is also regulated by the applicable Nominal Interest Rate and Pricing Modification Policy.
2. The fees are charged to customers for the services provided, unless otherwise stipulated in an agreement concluded by and between the relevant customer and the Bank.
3. The Bank shall charge the applicable fee along with any actual costs incurred in connection with the service provided.  
The actual costs shall be:
  - 3.1. postage charged for express deliveries and air mail, deliveries made using special services, postage charged for various parcels and costs of transport,
  - 3.2. commissions and fees charged by other domestic and international financial institutions, incurred during the provisions of the relevant service,
  - 3.3. legal representation fees, court expenses, claimed payments under a bill of exchange, lawsuit regarding the bill of exchange, honoured bill of exchange, etc.
  - 3.4. Other actual costs as determined by the competent senior director or the Board of the Bank.
4. The fees for the services provided to foreign banks are charged and collected in the currency of the transaction.
5. The fees charged for international transactions that the Bank carries out for customers in the country are calculated and collected in EUR. As regards foreign exchange operations, the basis taken to calculate the relevant fees shall be the service price in foreign currency converted to EUR using the official sell rate of OTP banka d.d., applicable on the day of provision of the service. As regards the transactions tied to an FX rate, the basis taken to calculate the relevant fees shall be the service price in foreign currency converted to EUR using the middle exchange rate of OTP banka d.d. applicable on the day of provision of the service, save for guarantee transactions, where official sell exchange rate of OTP banka d.d. applicable on the day of provision of the service shall apply. The Bank shall execute international orders, given by any customer, in accordance with the General Operating Terms and Conditions of the Bank, whereas related fees will be charged and collected in accordance herewith.
6. Bank's fee receivables shall fall due on the day specified in the settlement, agreement, debit records, etc.
7. The Bank shall charge penalty interest on all overdue receivables referred to in paragraph (1) above, in accordance with the Decision on Interest, from the due date until the day they are settled.
8. The Bank shall charge to the payer any commissions and costs payable to the foreign correspondent bank.
9. The fees charged for the services provided under the Decision are the minimum fees. However, the Bank may charge higher or lower fees depending on the risk of the transaction, operating costs, and the prevailing market rates.
10. From the day it enters into force, this Decision shall apply to all ongoing transactions that are subject to the Decision, noting that, where a pricing range is specified, the maximum value shall apply unless agreed otherwise.
